



## ST. PIUS X SCHOOL TUITION RATES SCHOOL YEAR 2016-2017

### Kindergarten to Grade 8

Family rates are calculated for both Catholic and Non-Catholic families. Each year, Catholic Churches pay into a Diocesan pool of funds that support Catholic Education within Diocesan Schools. Therefore, the Catholic rate is given only to those families who are active registered members with an area Catholic Church.

As per Diocesan guidelines, tuition may be paid with one of three methods through FACTS Tuition Management:

- *a one-time yearly payment (no FACTS fee applies) or*
- *two semi-annual payments payable in July 2016 and January 2017 (a one-time \$10 FACTS fee applies) or*
- *eleven monthly payments with the first payment due on JULY 5<sup>th</sup> or 20<sup>th</sup>, 2016 and the final payment due on MAY 5<sup>th</sup> or 20<sup>th</sup>, 2017 (a one-time \$43 FACTS fee applies).*

All registration fees, tuition and activity fee payments must be made through an ACH transaction with FACTS Tuition Management. Financial Aid is available for those who qualify. Contact the school office for more information.

#### REGISTRATION FEE (NON-REFUNDABLE):

For new and returning students, the registration fee is \$75.00 per student payable through FACTS with a one-time deduction on July 5<sup>th</sup> or 20<sup>th</sup>, 2016.
